3. Clinical and Ethical Encounter Group for Graduates of the Dynamic Psychotherapy Program

Activity Description

The study group is targeted to experienced psychiatrists, psychologists, and clinical social workers who, in addition to obtaining terminal degrees in their fields, have completed a 2–3 year Psychoanalytic Psychotherapy Training Program.

In small group discussions of clinical moments, emphasis is placed on the clinician's emotional reaction to something the patient said or did. The clinician's awareness of an unsettling, frustrating, or surprising feeling is part of the clinical moment and is often key to an important dynamic in the intersubjective interaction.

Often, the teaching session is taken up by group discussions of layers of meaning radiating out from the clinical moment. Understanding the clinical encounter is an effort to establish safe emotional authenticity by both parties through boundary-respecting transference/countertransference enactments as a foundation for the therapeutic alliance and possibly deepening the relationship.

Learning Objectives

- 1. Demonstrate sensitivity to unconscious communication to further self-reflection and self-understanding in order to attain a deeper understanding of the patient.
- 2. Describe the usefulness of countertransference as part of the therapist's beliefs, values, fantasies, needs, and limitations in analyzing clinical encounters.
- 3. Describe how attention to the earliest manifestations of affect and defense in the here and now is fundamental to respecting the patient's deeper subjectivity and forming an ethical therapeutic alliance.
