Discussion will focus on clinical interventions and case formulation, demonstrating the relevance of classical analytic principles to psychotherapy today even when working with difficult patient populations and clinical settings different from those often presented in analytic literature. This discussion will provide concrete examples of "what to say, when" in psychotherapy that attendees can apply to their own clinical work. Attendees will have the opportunity to discuss the material together in "break out" chat groups, and a moderator will guide the following question and answer period where you can pose questions to Logan and Jill regarding the case.

**Logan Hall, LCSW**, is an early career professional and current student in the 2nd Intensive Year of the Psychoanalytic Center of Philadelphia's Adult Psychodynamic Psychotherapy Training Program. He is a Licensed Clinical Social Worker, graduate of Widener University's Center for Social Work Education (Chester, PA). He has currently been practicing for three years in a community mental health clinic in the city, and has most recently launched in part-time private practice in Center City Philadelphia. His clinical work is with people of all ages facing a range of issues including depression, anxiety, trauma, and difficulty in relationships. He has a special interest in providing psychotherapy to the LGBTQIA\* population.

**Jill Ragozzino McElligott, LCSW**, received her certification in Adult Psychoanalysis from the Psychoanalytic Center of Philadelphia in 2009. She maintains a private practice in psychoanalysis and psychoanalytic psychotherapy in Haverford PA, and also works as a Senior Clinician and Supervisor in the Bryn Mawr College Counseling Center. She teaches in the residency training programs at Temple and Rowan Universities, and was asked to join Temple's psychodynamic teaching seminar. Jill has developed multiple courses on the clinical process at PCOP and was recently appointed as a Supervising Psychoanalyst. She has been honored with teaching awards at Temple and PCOP.
