ANALYTIC PRINCIPLES FOR THE REAL WORLD: WORKING WITH RESISTANCE

In this latest installment of our case conference series, PCOP psychotherapy student lrene Hurford, MD will present a case to discussant Sally Holtz, PhD, psychoanalyst and PCOP faculty member, with a focus on 1) identifying resistance in its various forms and 2) ways to intervene when encountering resistance.

Discussion will focus on clinical interventions and case formulation, demonstrating the relevance of analytic principles to work with patients different from those often presented in analytic literature. This discussion will provide concrete examples of "what to say, when" in psychotherapy that attendees can apply to their own clinical work. Attendees will have the opportunity to discuss the material together in "break out" chat groups, and a moderator will guide the following question and answer period where you can pose questions to Irene and Sally regarding the case.

Dr. Irene Hurford was founder and clinical director of the Psychosis Education, Assessment, Care, and Empowerment (PEACE) program at Horizon House, Inc, which has become a leading First-Episode Psychosis (FEP) program across the United States. She was the founder and director of HeadsUp at the University of Pennsylvania, where she led Pennsylvania-wide efforts at FEP services program evaluation, and programmatic training in FEP Coordinated Specialty Care service implementation and delivery. Currently Dr. Hurford is in private practice in Jenkintown, PA, where she continues to have a special interest in working with people with psychosis.

Dr. Sally Holtz is a psychologist and psychoanalyst. She is on the faculty at PCOP and at the Psychoanalytic Association of New York as well. Additionally she is clinical assistant professor in the psychiatry department at the University of Pennsylvania medical school, where she teaches and supervises psychology post doctoral fellows and psychiatry residents. She has been in private practice for over 35 years.
