# It's Not All About You: How Cultures Influence Toddlerhood

How infants and toddlers separate and individuate from their families has been formally studied largely from a Euro-American viewpoint. This conference aims to bring data from around the world to bear on the separationindividuation process. Separation-individuation occurs simultaneously, and intertwined with, the development of attachment patterns, but has received much less cross-cultural attention, a deficit this conference will attempt to address. Cultures are highly variable in how they influence early child development, and the presenters for this conference are leading experts in the influence of culture on development.

# **BAMBI CHAPIN, PHD**

Dr. Chapin is Associate Professor of Anthropology and Chair of the Department of Sociology, Anthropology, and Public Health at the University of Maryland, Baltimore County (UMBC). She is the author of Childhood in a Sri Lankan Village: Shaping Hierarchy and Desire.

# **GILLIAN GILLISON, PHD**

Dr. Gillison is Professor Emerita of Anthropology at the University of Toronto. She also frequently worked at the Laboratoire d'anthropologie sociale at the Collège de France. She is the author of She Speaks her Anger: Myths and Conversations of Gimi Women and Between Culture and Fantasy: A New Guinea Highlands Mythology.

#### **ALEXANDRA M. HARRISON, MD**

Dr. Harrison is Associate Professor of Psychiatry (Part-Time) at Harvard Medical School at the Cambridge Health Alliance, a Training and Supervisory Analyst of Child, Adolescent, and Adult Analysis, at the Boston Psychoanalytic Society and Institute, and Core Faculty at the Early Relational Health course at University of Massachusetts Chan Medical School. She is the President and CEO of the nonprofit Supporting Child Caregivers, which collaborates with local institutions to offer helpful information to child caregivers, with the goal of supporting healthy development of children across the globe.

### **ED TRONICK, PHD**

Dr. Tronick is one of the nation's most accomplished and best-known developmental and clinical psychologists. Developer of the Still-Face Paradigm, he is Professor of Psychiatry and Pediatrics at the University of Massachusetts Chan Medical School. He has published 8 books and more than 300 scientific papers.
